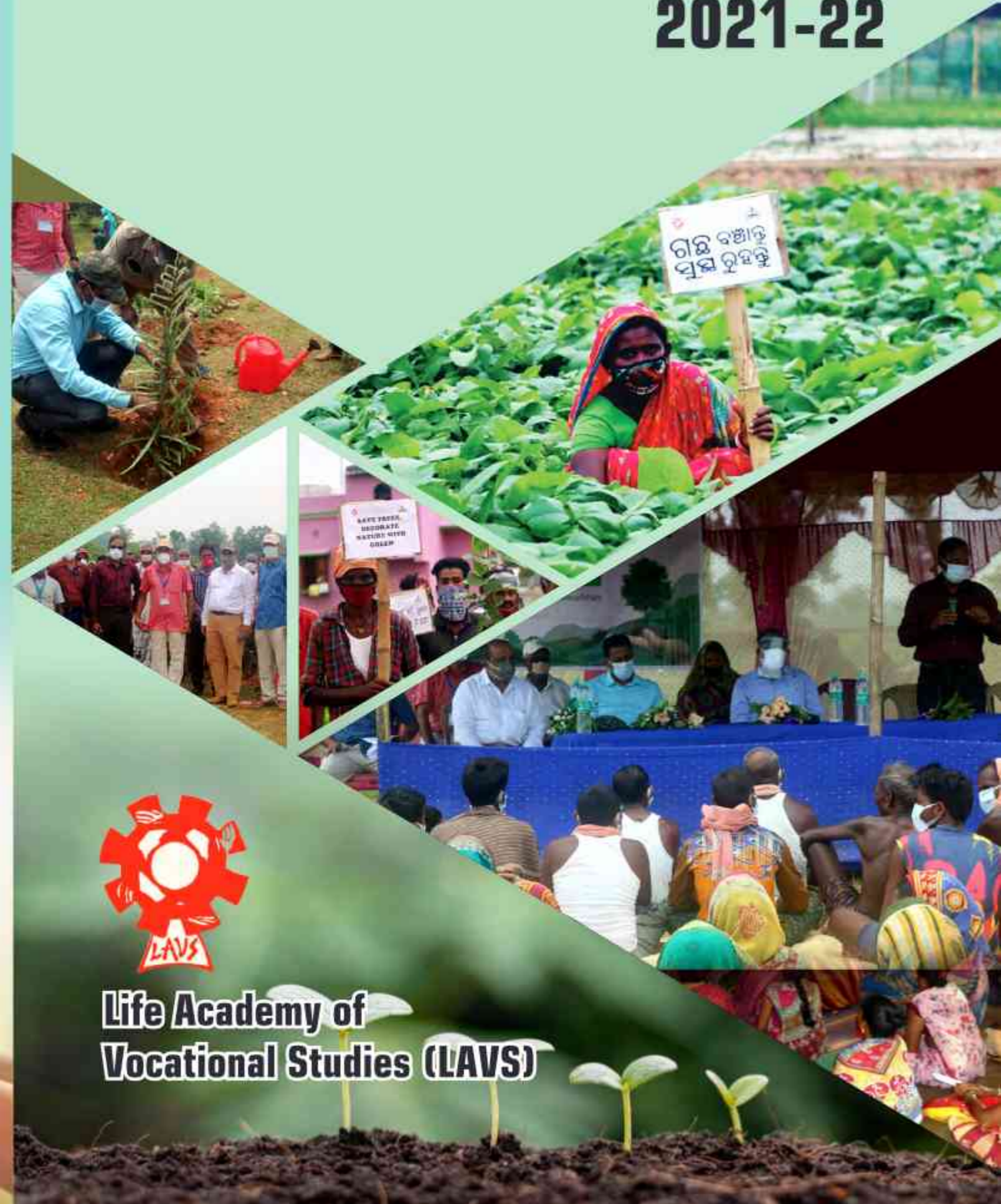

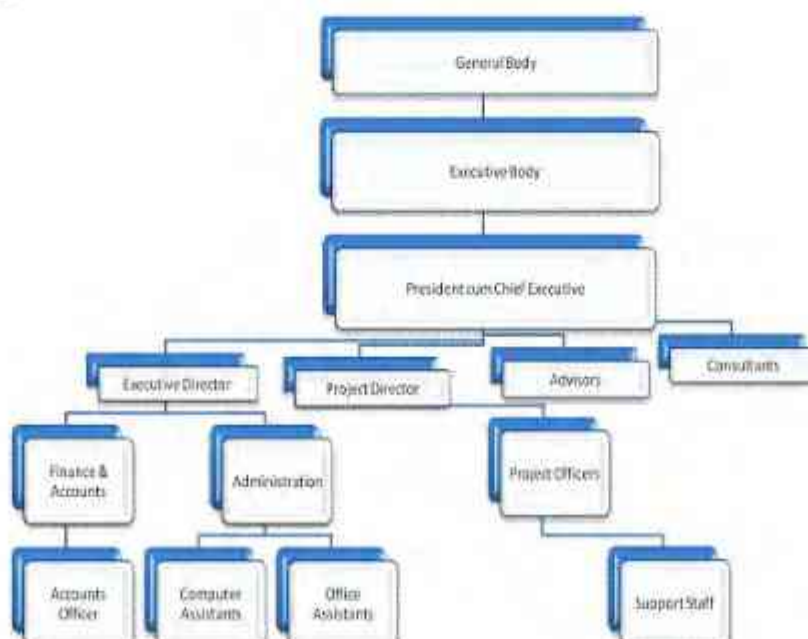

ACTIVITIES DURING FISCAL YEAR 2021-22

POPULARIZATION OF MILLETS IN TRIBAL AREAS

The nutrient-rich millets that were fast fading away from agricultural landscape are now making a comeback in several districts of the state thanks to a special programme for its promotion in tribal areas undertaken by the Millet Mission

and its high nutritional value. In 2017-18, the special programme for promotion of millets in tribal areas was launched in 11 districts with the objective to increase millet production with marketing support and promote millet-based food processing entrepreneurs.



LAVS has been associated as Facilitating Agency in the implementation of a 'Special Program for Promotion of Millets in Tribal Areas' in Pottangi Block of Koraput District since 2017. Under the programme, improved technologies like line sowing and transplantation are adopted with less seed and root intensification. Input incentives are being provided @ Rs 2,500 per ha for medium and large farmers and Rs 5,000 per ha for small and marginal farmers by the Mission. Programmatic thrust of intervention include

- (a) Promoting Household Consumption
- (b) Improving millet productivity
- (c) Promoting Processing Units and
- (d) Establishing Market Linkages for sale at fair price.

Observation of Food Festival

One Food Festival was organized in front of the Block Office Pottangi on 3rd and 4th Sept. 2021. The objective of the Nutrition week food festival elaborate by the coordinator and Inauguration by P.A., ITDA with BDO and other all block officer with line dept.

The main objective of the programme is the importance of millets & its consumption, nutritional values through it is a massive programme and special programme all the members of CBOs to propagate these message in their in their village level to aware the self help group on the cost benefits and consumption there is support of women SHG/CBO. The SHGs are taken time to trained and to their presenting in different types of item in millets i.e. Mandia soup, Mandia Laddu, Mandia Bara, Mandia Pajee, with Mandia Chop & Mandia Pakudi etc.

62 persons participated in the program.

Campaign In Villages to Increase Awareness on Nutritional and Health Benefits of Millets

A four-day campaign was launched by Life Academy of Vocational Studies (LAVS) covering the entire Pottangi Block of Koraput district; commencing from 3rd September 2021 to end on 6th September 2021. At commencement a Nutrition Ratha was inaugurated by the GPO, CDPO, OLM BPO, Mission Shakti BPO with our FPO Directors. The focus was on production of millets (Ragi).



The objectives of the programme were:

1. To sensitise the farmers to involve with this programme.
2. The importance of millets (Ragi).
3. Nutrition values on health aspect.

LAVS covered all the Grampanchayats of Pottangi Block, using Public Address System to sensitise the farmers on the above mentioned objective. When consuming any food substances, be it millets or other cereals, LAVS advised to go for organic food as it increases the nutritional value and induces other physiological benefits such as getting rid of pesticides or harmful chemicals, it tastes better as-well-as have a higher nutritional value and there is very limited chances of water contamination.

The Community Resource Persons (CRPs) accompanied the Nutrition Awareness Ratha. They were distributing Leaflets carrying messages on nutrition among the different villagers. They covered most of the Grampanchayats in Pottangi block.

SOCIAL IMPACT ASSESSMENT STUDY

The State SIA Unit, Nabakrushna Choudhury Centre for Development Studies (NCDS) have entrusted LAVS the task of undertaking the Social Impact Assessment Study for acquisition of private land for shifting of Rayagada-Kerada Road between Rayagada-Leda for construction of 3rd Railway Line. The size of the land to be acquired was 7.508 Acres from 3 villages; namely; Sunkarimetu, Lenda [Lada] and Pitamahal. It is a linear project. LAVS carried out the study based on the standard tools and templates prescribed by the State SIA Unit. All the actual title holders were identified by the process of the SIA study. During the survey, it came to knowledge that out of 29 plots, 31 households were affected, but the study team found only 30 households, whereabouts of the rest 1 household could not be ascertained.



The findings of the SIA study would certainly be beneficial to the implementing agency to prepare an Action Plan according to the needs and aspirations expressed by the affected people. Apart from the individual opinions, regarding the overall benefits and losses due to implementation of the project, the survey team also collected information from different sections of people through Focus Group Discussions (FGDs). All findings were reflected in the report submitted to NCDS.

MEGA PLANTATION IN MAYURBHANJ DISTRICT

Although the state of Odisha a large area of land under forest coverage with 10 reserve forests and every year the forest coverage is increasing, at times it becomes subject to degradation/ dilapidation owing to several reasons; the biggest being forest fire. Following the forest fire in the foothills of Similipal reserve forest in Mayurbhanj, the eco-system was imbalanced to a large extent.



LAVS views forests as part of the larger physical, social, and economic landscape, and works with forest-dependent communities to plan preservation, conservation, and utilization of these shared natural resources.

LAVS thus helps build a larger pool of farming communities to participate for forest conservation and regeneration where the continuum of forests, agriculture and economic opportunities are appreciated together.

As part of initiatives, LAVS partnered with GROW TREES.Com to plant 3 million trees in Mayurbhanj district popularly known for its Similipal Biosphere. In this context, LAVS developed two mega Nurseries in Bisoi and Shamakhunta Blocks of the district with potential to raise 3 million saplings of forest species during the year. This has resulted in creation of more than 15000 wage days for the local people engaged in developing and raising 3 million saplings of different varieties.

The initiative covers 37 villages across these 2 [two] blocks and plantation of the saplings were done in 73 patches [48 in Bisoi and 25 in Shamakhunta]

PROMOTION OF FARMERS PRODUCER ORGANIZATION

LAVS promoted one Farmers Producer Organization; Panchabatmali Producer Company Pvt. Ltd. having its administrative office at Badagaon of Pottangi. It was established in in 2017. The present area of coverage consists of two blocks, Pottangi and Semiliguda. The primary objective of the FPO is to promote inclusion of more no. of farmers in agri-horticultural practices, to expand area of land covered under cultivation, establish linkages with markets, enhance quality of farm products by value addition, introduction of advanced methods in agri-horticultural practices, gradation and ensure adoption of package of practices, and most importantly promoting organic and natural farming.



This year it has been appointed as the procurement point (Mandi) for production of Millets in the block.

As a part of its implementation strategy, it has identified 435 nos. of progressive farmers, capacity building of farmers, conducting awareness campaigns; this year especially for Millets on household consumption and marketing. The marketing (procurement of Millets in the Mandi ensures that the farmers get the price for their product as fixed under the MSP (Minimum Support Price) fixed by the state Government, Odisha.

458 nos. of farmers of two blocks, Pottangi and Semiliguda have been collectivized into Producers Groups for 'Synchronized farming' and 'Collective marketing' of vegetables. The farmers are provided with handholding support and mechanizing the farming process.

Four Community Hiring Centres have been established at for different and strategic places, namely Taupadar, Deopottangi, Sambai and Peturu. The objective of the establishment of CHCs is to provide agri-horticultural implements on an affordable rate to the needy farmers. The rates for hiring such implements are decided by the community members (farmers).

Under the initiative, one Seed Centre has been established to promote use of indigenous/ traditional seeds which are resilient to impact of climate changes. During the period under report, Kalarahanga, an indigenous seed of Ragi has been selected using PVT method (Participatory Variety Trial).



Further under this initiative, one Processing Unit for threshing and grading was established in the initial stages of functioning of the FPO at Taupadar with support of NABARD, EO, Odisha. During the period under report, the unit has procured 497.95 Qntls. of Millet (Ragi) for threshing/ grading and marketing.

PREPARING SITE SPECIFIC WILD LIFE CONSERVATION PLAN

LAVS was bestowed with a responsibility of preparation of a Complete and Comprehensive Site Specific Wild Life Conservation Plan (SSWLCP) as per the Forest Conservation Act, 1980 with all amendments thereto and as per prevailing GOI Guidelines and current practice and procedure applicable under the laws of State of Orissa Forest Dept. and OPTCL for construction of proposed EHT Transmission lines in the state of Odisha.



The plan covered an area of 3.305 Hectares.

The project was about approval of a transmission line that passes through area of 3.053 Ha. in Bonai. The railway track connects Bonai to Bimlagarh. The line passes through forest and non-forest areas. The length of the transmission line is 19.944 KMs, out of which the line passing through is of length 0.944 KMs.



The Zone of Impact (Zoi) comes in Sundargarh district. Sundargarh is under North Western plateau as per Agro Climatic Zone of Odisha. The area is not a part of National Park/ Sanctuary/ Bio-sphere Reserve. It also does not come under any wildlife corridor. But wild Boar, Hyena, Porcupine, Bear, Jackal etc. are noticed around the applied area. Also the movement of elephants is noticed in the applied areas well as in the nearby areas. Except that some snakes, reptiles and Birds are also seen in the applied area. The Zoi is a Plateau in total. Paddy is the main crop followed by Maize, pulses, highland paddy and vegetables. Horticultural crops like Mangoes, Jackfruit have been cultivated in a greater scale.



NATURAL RESOURCE MANAGEMENT FOR SUSTAINABLE AGRICULTURE

Micro Irrigation

Creation of irrigation potential and utilization of ground water and various water resources is one of the important components of NRM intervention. As part of this, LAVS has facilitated irrigation potential for 183 acres of land in Pottangi Block of Koraput district under 'Integrated Watershed Development for Rehabilitation of Degraded Soils and Climate Change Adoption' supported by NABARD. The irrigation potential has been created through dug well, check dam, DBI and farm ponds. Through this intervention, 228 beneficiaries got assured irrigation to their crop field bringing additional areas under cultivation.

Land & Water Management

During the reporting year, 146 acres of waste land were converted into cultivable land through plantation and top soil management activity. 563 acres of land in Koraput district were brought under NPM practice, biological farming, integrated nutrient management. Promotion of high value vegetable crops like Ginger, Brinjal, Beans and Sweet potato as climate resilient crop has become an appreciable initiative for crop diversification and enterprise promotion.

Creation of additional irrigation potential and cultivable area led to diverse and improved agriculture practices by the tribal farmers in watershed area.



WDF - CLIMATE PROOFING OF WATERSHED

The WDF-NABARD soil project has been launched in FIP completed watersheds in different districts of Odisha out of which Koraput district is one among them. The project is being implemented by LAVS with the objectives of enhancing the resilience of vulnerable farmers by stabilizing these watersheds with additional soil and water conservation measures, improve the soil fertility and productive status, sustainable crop production and ensuring food security, measures to adapt climate risk and knowledge management with capacity building of the stakeholders. Various interventions and IG activities have been implemented under this project as additional measures in the completed watershed to address climate change adverse impact.



Key Highlight of the Project:

Zero energy cool chambers (ZECC) system of storage was introduced at watershed level for storage of vegetables in order to reduce the problems of post-harvest losses at farmers' level.

Context / Rationale:

Farmers used to sell their vegetables in the local markets just after the harvest. Transporting the crop in gunny bags on local transport to markets induce considerable stress on them. Due to lack of any storage facilities in watershed village, the considerable amounts of vegetables were spoiled after harvest. Losses occur in both ways i.e., qualitative and quantitative terms. The spoilage of vegetables can be controlled by reducing the storage temperature and increasing the relative humidity.

Advantages :

- Low cost & eco friendly
- On farm storage
- Enough time to decide the marketing destination of the produce

PROMOTION OF COMMUNITY LEVEL INSTITUTIONS :

The recent trend in the development sector is promotion of sustainable enterprise to address the socio-economic issues at hand. LAVS has been working closely with enterprise-oriented producer groups at village level for production, aggregation and value addition of agriculture, horticulture and forest-based products to reach the economic altitudes of business. It has strengthened the capacities of community level institutions, such as village development associations, self-help groups, producer groups and producer companies to identify people's needs and include those in mainstream programmes through enhancing participation in Palli Sabha, Gram Sabha and other appropriate forums by actively getting involved in programme planning, implementation and monitoring.

SKILL BUILDING & LIVELIHOODS

LAVS strives to reach out to the vulnerable sections of the community like the marginal tribal farmers, and rural community living below poverty line, especially women who bear the brunt of vagaries of rural life, whether it is in agriculture, animal husbandry or in managing water for their households or farms.

Empowering Women

LAVS, work towards empowering women through Self Help Groups (SHGs) by building their capacity to manage finances, through savings and accessing credit, developing their skills for specific income generation activities, thus making women independent by leading them towards financial stability.

The initiatives of women collectives aim to address the inclusion of the poorest of the poor in the development programs. The program seeks to empower individuals and groups of women by providing them with the skills and knowledge they need to effect changes in their environment.

During the period under report;

- Our number of women Self Help Groups (SHGs) increased to 626, from 568 of last year.
- Number of women engaged in income generating activities increased by 12%.
- From making eco-friendly leaf plates, incense sticks and lip smacking sweet and savory items, the women lived up to their motto of self-help and solidarity while earning something for themselves.
- They met the current challenges of the COVID -19 Pandemic by creating opportunities out of them. From making masks, hand wash, phenyl to preparing and serving food for relief work in initial difficult days of lockdown.



Transfer of Technology for Women Entrepreneurship

Facilitated and coordinated drudgery reduction and income generation through enterprise, transfer of technology to women enterprises with project support from NABARD and Govt. of India.

- 2) In the case of Income and Expenditure account, of the Excess of Income over Expenditure of its accounting year ending on 31st March, 2022.

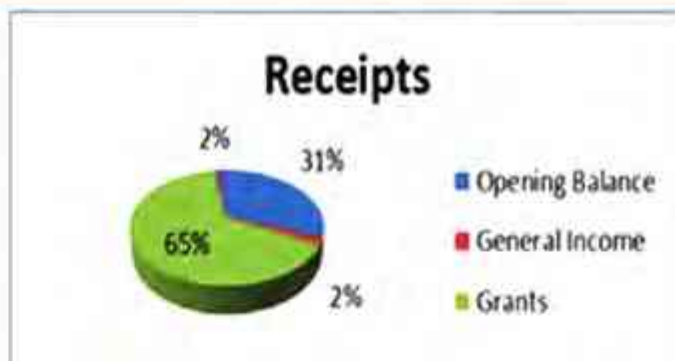
